MINUTES OF THE FOURTEENTH ANNUAL GENERAL MEETING  
OF THE FORTY PLUS CYCLING CLUB, HELD AT  
"THE CASTLE", 26, FURNIVAL STREET, E.C.4,  
ON SATURDAY, 6TH MARCH, 1965.

The meeting commenced at 3.10 p.m. with 28 members present. This number was subsequently increased to 31.

The Secretary, Mr. Seymour, explained the absence of the Chairman, Mr. Irving, who was in hospital after an operation. It was then proposed by Mr. Wooder, seconded by Mr. Stewart and agreed that Mr. Tackley should act as Chairman for this meeting.

Apologies for absence had been received from Messrs. Clark, Irving and Fitzpatrick.

1. Confirmation of Minutes of Thirteenth A.G.M.

These Minutes had been circulated to all members of the Club.

It was moved by Mr. Covington, seconded by Mr. Drewett and agreed that the Minutes as circulated be accepted as a true record of what took place last year. They were accordingly signed by the Acting Chairman.

2. Matters Arising from the Minutes Not Included in the Agenda for the Present Meeting.

There were no matters arising.

3. Secretary's Report.

This had been circulated to all members of the Club.

In enlarging on his report, the Secretary congratulated those who had made such successful endeavours to increase the membership to its present record of 135 - particularly Mrs. Lang, who had been outstandingly enthusiastic in this field. He repeated that he thought the Club gave good value for money and was of the opinion that it was now standing on a very sound foundation which should survive any future setbacks. He hoped that every member would attend a fixture at least once a year, as it was their companionship we wanted, not just their names. Records showed that about 40% of the membership attended runs during the year, which was quite creditable, though he would like to see this percentage higher. He appealed for someone to fill the still vacant office of Social Secretary, particularly as Mr. Irving, who had been mainly responsible for the organization of the last two Annual Dinners, might not be as fit after his operation as heretofore. Also Mr. Wooder should be relieved of some of the work which he took on in this respect. We had very enthusiastic officers, this being one of the reasons for the Club's success; but these should not be overburdened. He closed with an account of two of his past experiences which illustrated the great spirit of comradeship existing among cyclists under adverse conditions and said that it was such experiences which made him proud to belong to a Club such as ours.

It was then proposed by Mr. Drewett, seconded by Mr. Covington and agreed that the report be adopted with acclamation.

4. Treasurer's Report and Audited Accounts.

These had been circulated to all members.

In enlarging on these, the Treasurer, Mr. Knapp, pointed out that the cost of the Handbook had increased but that advertising was down. The latter was due to the C.T.C. Gazette, in which we advertised, now being issued bi-monthly instead of monthly. The price would, however, be back to the old one of £7.10.0 for 1965. The drop in donations was probably due simply to the fact that members thought them no longer necessary. These had never been asked for but came in when there was any particular expense involved, e.g. the purchase of a duplicator.

The Secretary asked the Treasurer if he was happy to keep the subscription at 10/-, to which the Treasurer replied that he thought it adequate. The subscription had not been increased for 7 years, and Mr. Wooder remarked that this was largely due to Mr. Pemberton's supply of paper at cheap rates. The Treasurer stated that "Signpost" worked out at 2/6d. per member for four issues, which was very economical, and he thought Messrs. Wooder and Tackley were to be commended on their economical system of running the issuing of "Signpost".

5. Consideration of the Following Proposal from the Committee. -

"That a form of commuted membership giving 5 years membership for an advance payment of 4 years current subscription be inaugurated."

The Chairman stated that this was now open for discussion.

Mr. Covington asked if this subscription would give everything that the members enjoyed at present and was told that such was the case.

Mr. Stewart asked the reason for the proposal and was told by the Chairman that it was to encourage members to stay with the Club longer and to make administration easier (e.g. there would only be one collection of subscription and one entry in the books per member for 5 years instead of one being necessary every year).

In reply to a question as to what would be done with the money, the Secretary said that it would be invested - it was not intended to tie the money up in a special account.

The Treasurer said that the scheme, if passed by this A.G.M., would commence on 1st January, 1966, that by the A.G.M. for that year we should know how many wished to avail themselves of it and that he would then be able to make a suggestion as to how to deal with the money. He felt sure that we could make more than enough profits in investing the money to make up for the loss of one year.

Mr. Downey pointed out that we should need a special drive at the end of 5 years in case some of those who had taken out membership for 5 years did not wish to renew.

Mrs. White asked what would happen if we wished to increase the subscription and the Secretary explained that those who had already entered the scheme would be unaffected by an increase and would therefore benefit financially.

Mr. Johnson then proposed and Mr. Padley seconded the following:-

"That commuted membership be only available after 2 years ordinary membership."

This proposal was lost by a large majority and the original motion was carried nem.con.

At this point the President, Mrs. Lang, entered and apologised for her late arrival, which was due to the illness of her husband. The Chairman welcomed her and the meeting, through him, conveyed to Mrs. Lang their hopes for Mr. Lang's speedy recovery.

6. Election of Officers.

The following were elected:-

Social Sec.	The Secretary made a special appeal for one of those present to perform this work and stressed that the committee would give every assistance, adding that if no Social Secretary were found there might be no Annual Dinner but that if one were found he might be willing to organize other social functions in addition. As the meeting was unsuccessful in finding a member willing to fill this position, the Chairman passed on to the election of the six other committee members. The position was subsequently filled (see (c) of Any Other Business).		

Here came a break for tea, during which photographs taken on a recent Club run and kindly donated by Mr. and Mrs. James, were sold to members present, the proceeds to help defray expenses of the meeting.

Mr. Middleton proposed, Mr. Stewart seconded and it was agreed that the four existing Runs Leaders be elected to the committee. These were:-

Messrs. Cannon, Drewett, Warhurst, Wooder.

Two other committee members were needed and Messrs. Fletcher, Hankin and Middleton were proposed. A vote resulted in Messrs. Hankin and Middleton being elected.

The election of officers was finalised by a proposition from Mrs. Lang, seconded by Mr. Wooder and agreed that Mr. Fitzpatrick be elected as Auditor.

7. Any Other Competent Business.

(a) Club Tie.

Mr. Jefford asked if we could have a Club tie and several members present expressed interest in the idea. The Chairman suggested, and it was agreed, that this idea should be considered by the committee and asked that, in the meantime, members interested should let the committee members know.

(b) Vice-Chairman.

Mr. Cannon suggested that we appoint a Vice-Chairman, the idea behind the suggestion being that the Chairman and Vice-Chairman should be in touch before a meeting in order to ensure that one or other of them would be present. After discussion, Mr. Cannon agreed to a suggestion that the committee should elect a Vice-Chairman from among their members; Mr. Covington seconded this and the meeting also agreed.

(c) Social Secretary.

Mr. Drewett suggested coming back to nominations for Social Secretary as, since the subject had first been discussed, there had been late arrivals who might be interested in the position. The Secretary again appealed for volunteers, not only to organize the

Annual Dinner but also to take some of the work of the social side off Mr. Wooder's shoulders. Finally Mr. Fletcher volunteered on condition that he could have an assistant and Mrs. Read volunteered for this latter work. It was then proposed by Mr. Hankin, seconded by Mr. Middleton and agreed by the meeting that these two members be elected jointly as Social Secretaries. The Club Secretary thanked Mr. Fletcher and congratulated him on "having the courage of his convictions".

(d) Handbooks.

Mr. Wooder suggested that these should in future be issued with the July issue of the Club Magazine each year but the Secretary reminded him that at a previous meeting it had been agreed that they be got out as early as possible and stated that, as it took 2-3 months to get this work done (sending amended Handbook draft off to the Printers, getting back and checking proofs, despatching to members, etc.) the earliest possible date was about the end of March. They had been later than this in 1964 owing to the alterations to the Rules, which had had to be passed by the A.G.M. before being printed. Normally, however, they could go out with the March issue of "Signpost", as would be done this year.

There being no other business brought up for discussion, the meeting closed at 5.55 p.m. with votes of thanks to the Acting Chairman, Mr. Tackley, and to Mrs. Seymour, who was acting as Minuting Secretary.

SECRETARY'S REPORT FOR 1964.

When I wrote my first report as your Secretary for 1959, I hardly expected to be writing these words for 1964. Perhaps this means, not so much satisfied acknowledgment from the membership, as the usual attitude of laissez faire in any amateur organization. I have no doubt your committee feel similar reactions, without any thoughts of false modesty however.

Without wishing to stress the foregoing remarks, I feel that it is high time that the members produced from their ranks a Social Secretary. Don Irving has carried on the tradition of the Dinner from Ted Groom admirably; but I feel sure he would be the first to admit that an expansion of social functions should be an individual responsibility in a club of this nature.

The activities of the Forty Plus read, once again, like something from the travel features of the Press. Runs held regularly every Sunday in all directions, Bank Holiday tourlets and invasion of foreign parts by the official parties have been supported by individual riders, penetrating, as was briefly mentioned at the Dinner, to places even to-day considered unusual.

The quarterly Magazine has been commended in writing on more than one occasion in 1964 and it is hoped that this is sufficient reward to <sup>St</sup>ewart Tackley for his efforts.

The Runs Leaders, as always, bore the brunt of the practical side of the Club activities. Without their work there would be, in effect, a club in name only. No doubt, seeking no praise, their efforts are rewarded by your presence on the fixtures.

The Dinner was a replica of the success of 1963, through the excellent work of Don Irving, and the numbers attending and financial result showed a very similar pattern.

The membership has increased considerably again, by 15, standing at 135 at December 31st. This, I suppose, is some reward for my constant nagging on this subject; but seriously, it can be said, without undue optimism, that a foundation has now been laid. But do not let that remark allow you to relax your efforts! This increase is reflected in the accounts, on which a separate report has been prepared by the enthusiastic Treasurer, George Knapp.

A more central venue has been found for the A.G.M. and your committee and I hope that the numbers attending will be at least equal, if not greater than for 1964. The sweetener of a slide show to follow is to be repeated.

Finally, Marjorie and I hope to meet as many of you as we possibly can during 1965.

TREASURER'S REPORT FOR 1964.

At the end of my first year as your Treasurer, I must thank all members for the co-operation I have received; the way subscriptions come in is a revelation.

The accounts for 1964 show a surplus of Income over Expenditure of £12.10.4, whilst stock of badges and transfers has been increased by approximately £10; against this we must allow £6 for depreciation of the duplicator, which leaves us roughly £16.10.0 to the good.

The Committee devoted a considerable amount of time looking into the question of introducing Life Membership and finally came to the conclusion that, for this Club, the scheme was not really desirable. Instead, a proposal will be made at the A.G.M. that members may pay a commuted subscription of £2 for 5 years membership, and it is hoped that this will meet with general approval.

MINUTES OF COMMITTEE MEETING  
HELD AT THE "CROWN & SUGARLOAF", GARLICK HILL, E.C.4  
ON FRIDAY, JANUARY 29TH, 1965.

Present:- Messrs. Cannon, Drewett, Fletcher, Knapp, Middleton, Seymour, Warhurst, Wooder.

Apology for absence received from Mr. Tackley.

The meeting commenced at 7.10 p.m.

In the absence of the Chairman, Mr. Irving, Mr. Drewett was unanimously elected to conduct the meeting.

Minutes of Last Meeting.

These were accepted as a true record on a motion by Mr. Cannon seconded by Mr. Wooder.

Matters Arising.

Mr. Seymour said that he had received a communication from Mr. Tackley that the typewriter was now being serviced at a quoted price of £4-£5, which figure might be increased in the unlikely event of additional trouble being found on inspection.

Also, on the subject of the Dinner, he wished to clarify the question of refunds, as he felt it to be unfair that different treatment had been accorded at various times although, of course, he did not suggest action in any way to discourage attendance. After a short discussion it was proposed by Mr. Wooder that, to qualify for a refund, application must be made seven days before the function, and this was passed unanimously. Mr. Seymour was also informed, on his raising of the subject of gratuities, that 10% would be payable to the "Talbot" in future. Mr. Drewett reported that he had contacted his suggested alternative band and had been quoted a figure of £15. After discussion, Mr. Knapp proposed a deferred decision on any change and this was passed unanimously.

Secretary's Report.

The Secretary read correspondence relating to enquiries regarding membership and also that received from members paying subscriptions to him. The year had concluded with a membership of 135 - a very creditable advance of 15 on 1963 - and 5 new members were already enrolled for 1965. Several recent enquiries were on hand.

The Secretary's report was accepted on a proposition by Mr. Wopder seconded by Mr. Warhurst.

Treasurer's Report.

The Treasurer submitted a draft of the accounts for 1964 and said that he considered the situation very good. A profit of approximately £12 had been made; in addition there was an increase in the stock of badges and transfers. He read correspondence received from members when renewing their subscriptions.

Mr. Wooder proposed a vote of thanks to the Treasurer together with the acceptance of the report and, seconded by Mr. Cannon, this was passed unanimously.

Annual General Meeting.

The Secretary reported that he had received a letter via Mr. Tackley from the "Castle", Furnival Street, E.C.4, quoting a price of two guineas for the use of a room from 2-8 and had confirmed the booking. Regarding the question of refreshments, the Licensee would consider if these could be provided and would communicate further on this. It was hoped to repeat the slide show afterwards, inaugurated in 1964.

A separate Treasurer's report would be circulated.

Regarding commuted membership, the Secretary was instructed to put a formal proposition of 5 years for 4 years payment on the agenda, from the committee. The Treasurer said that he would defer alternative ideas on investment of Club funds until this scheme was passed and in operation.

Advertising.

The Secretary read correspondence he had written in connection with the Club advertisement in "Cycle Touring". He had taken himself the responsibility for continuing the insertion in the December-January issue and now asked for instructions as to the future. After a short discussion, a unanimous decision was passed to maintain the continuity and the Secretary was instructed to convey these instructions to the C.T. C. Advertising Department.

Runs Leaders' and Editor's Reports.

Mr. Wooder reported 11 away for the Christmas holiday, when Bob Hardy paid a visit to Great Easton. The impromptu runs had been well attended, with more ladies in evidence, and quite justified their existence. On Jan. 3rd 12 out all day from Ongar with lunch at Sawbridgeworth. On Jan. 17th 15 out. On Jan. 24th, the official Eastern run, 12 out. He had 12 booked for Easter. Stan Russell would be leading the Whitsun tourlet.

Mr. Cannon had made enquiries regarding lunch on the Saturday for his coming week-end to Dial Post but, as the quotation was considered too expensive, he would pursue possible alternatives.

Mr. Warhurst gave the attendance for the Christmas lunch at Bricket Wood as 34, with quite a good meal. He hoped to repeat it in 1965. On January 17th, 13 to elevenses, 17 to lunch and home to tea on a bad day for weather.

Mr. Drewett reported on December 13th to Langley, 5 to elevenses, 9 to lunch and 2 stayed out to teat a new venue for us at Tolmers, Newgate Street, which was quite good. The impromptu run on January 10th attracted 12 to elevenses and 8 to lunch.

In the absence of Mr. Tackley there was no Editor's report.

The Runs Leaders' reports were accepted with appreciation on a motion by Mr. Middleton seconded by Mr. Seymour.

Any Other Business.

Mr. Warhurst said that he had received an invitation from Mr. Jefford for the Club to visit the Social Club of his firm at Sundon, near Luton, on May 9th, coupled with a visit to Mr. and Mrs. Jefford at their home for elevenses. This was accepted with appreciation and Mr. Warhurst was asked to confirm it. A tangible acknowledgment in a suitable form would be made to the Jeffords. Mr. Warhurst also reported that Tom Pearce was to have an operation for hernia.

ON FRIDAY, APRIL 9TH, 1965.

Present.

Mrs. Read, Messrs. Cannon, Drewett, Fletcher, Irving, Knapp, Middleton, Seymour, Warhurst, Wooder.

An apology for absence was received from Mr. Hankin.

The meeting commenced at 7.05 p.m.

Minutes of Last Meeting.

These were accepted as a true record on a motion by Mr. Knapp seconded by Mr. Wooder and were signed accordingly by the Chairman.

Matters Arising.

There were no matters arising.

Secretary's Report.

The Secretary read correspondence received since the last committee meeting, sent to him with renewals of subscription. There were one or two enquiries regarding membership on hand but these were of too recent date to justify follow-up at present.

The Secretary's report was accepted with appreciation on a motion by Mr. Drewett seconded by Mr. Cannon.

Treasurer's Report.

The Treasurer reported having received 120 subscriptions. There were 22 still outstanding for 1965. Accounts for advertising, room hire and teas at the A. G. M., less a donation, and Handbooks, had been paid and amounted to £22.11.6. This left a cash balance in hand to date of £127.19.0. The 22 outstanding subscriptions were examined in detail and appropriate action agreed in the varying circumstances. A final figure would be available at the next meeting. On the subject of the cost of providing teas for those attending the A.G.M., Mr. Seymour said that he considered that a position had now been reached when it might be advisable to charge a nominal sum for refreshments.

The Treasurer's report was accepted with appreciation on a motion by Mr. Warhurst seconded by Mr. Wooder.

Annual General Meeting.

The draft minutes were accepted as a true record of the proceedings. Mr. Seymour asked to be refreshed on the subject of advertising charges. Mr. Knapp said that, in 1963, £7.10.0 was paid for 12 insertions in the C.T.C. Magazine. As it was converted to bi-monthly, this paid for 1964 also, except that it was agreed to have a box surround at an extra charge of £3.15.0. As this was to be continued, the new charge was £7.10.0 for six appearances per year. On the subject of commuted membership, the Chairman gave as his ruling that this alteration to the rules, which he accepted as implied, which was passed at the A.G.M., would be put into operation for subscriptions for 1966. No precedent had been set for any successful motion to be applied to the current year.

Annual Dinner.

On this subject, Mr. Fletcher asked for details as fixed to date. He was informed that the "Talbot" had been booked for the function for Saturday, 6th November. Arthur Lyme had not yet been contacted regarding the availability of his band. (At this point Mr. Wooder suggested that a pianist would be preferable to a band and the social evening thus provided more suitable to the occasion. This idea being received favourably, it was agreed to proceed on the suggestion). An extension of licence would have to be arranged. Regarding the toasts, it would be necessary to procure a chief speaker to propose the Club and also a Club member to welcome the guests. Circulars to remind members, etc. would be in the hands of Mr. Wooder. Specimen menus would be examined after receipt from the "Talbot" proprietors. It was hoped Mr. Groom would be prepared to accept the duties of M.C. The Social Secretaries were asked to report progress on the arrangements at the next meeting.

Runs Leaders' and Editor's Reports.

Mr. Warhurst had only one run to report - that on March 14th to Ayot St. Lawrence, which attracted 22 to elevenses at St. Albans and 22 to lunch. No tea stop was booked on the return.

Mr. Drewett reported three runs. On February 7th an impromptu venue attracted 15 to elevenses at the "Kia-Ora", 12 to lunch at the "John Barleycorn" at High Laver; with tea at home. On March 7th, again elevenses at "Kia-Ora", attended by 14 members, 12 to lunch at Sawbridgeworth, including a prospective new member, and 4 stayed out to tea. On April 4th, 12 to elevenses at Tolmers, Newgate Street, 10 to lunch at Harpenden and 5 to tea at Elstree.

Mr. Wooder reported on January 31st an impromptu run to Ongar for lunch, 13 to elevenses and 10 to lunch. On February 14th, from Widford to Billericay, 12 to elevenses, 6 to lunch. On February 21st - a run to support the East London T.A. Dinner - from Sawbridgeworth to Doddinghurst - was attended by 16 to lunch. On February 28th another impromptu run from Ongar to Widford and Crays Hill saw 13 to elevenses, 10 to lunch. On March 14th, on a circular trip, 10 members were present. On March 21st,

the official Eastern run, 12 out with 11 to lunch at Great Easton. He had 11 booked for Easter and 6 to 8 for Whitsun, 10 were going to Corsica and, provisionally, the same number for Normandy later in the year.

Mr. Cannon reported on the week-end to Dial Post on March 27th /28th. 10 met at Woolwich, increased to 11 at West Wickham for elevenses and 15 for lunch on the Saturday at Merstham. Tim Crawley was met by chance, staying at "The Gables". Numbers were maintained in the morning by being joined by a Miss Graham, a prospective member, since enrolled. At lunch at Capel numbers were increased to 17, and 11 went on to tea at Godstone, being joined by two later.

In the absence of Mr. Tackley, there was no Editor's report.

Any Other Business.

The questions of a Club tie and the election of a deputy Chairman were deferred until a further meeting owing to lack of time.

The meeting closed at 9.15 with a vote of thanks to the Chairman.

A letter was handed to the Secretary after the meeting, from Mr. Tackley, in which he apologised for absence owing to sickness. In it he brought up the points about the strict accuracy of the wording of the proposition passed at the A.G.M. regarding commuted membership and also the point of when this was to be inaugurated. Both these points had been dealt with by the Chairman in committee. He also wished to ventilate the question of the covers of the Magazine. He expressed his gratitude to the Runs Leaders for their willing co-operation in supplying reports on fixtures, a duty which he felt placed an additional burden on their time.

Present.

Mrs. Read, Messrs. Drewett, Hankin, Knapp, Middleton, Seymour, Tackley, Warhurst, Wooder.

In the absence of the Chairman, Mr. Wooder proposed, and Mr. Middleton seconded, that Mr. Tackley act as Chairman for the meeting. This was agreed unanimously. Mr. Tackley, in accepting, said that perhaps this would be the opportunity of dealing with the question of a permanent deputy Chairman. Mr. Middleton then proposed, and Mr. Wooder seconded, that Mr. Tackley be elected as acting deputy Chairman and this was agreed. Mr. Tackley, in accepting, expressed his appreciation of the confidence of the committee.

Apologies for absence were received from Mrs. Lang, Messrs. Cannon, Fletcher and Irving.

The meeting commenced at 7.10 p.m.

Minutes of Last Meeting.

These were accepted as a true record on a motion by Mr. Warhurst seconded by Mr. Drewett and signed by the Chairman.

Matters Arising.

There were no matters arising.

Secretary's Report.

The Secretary read correspondence he had received in connection with Club matters and enquiries for membership. There were none on hand at present necessary for follow up by area leaders. He had officially welcomed all new entrants. The report was accepted with approbation on a motion by Mr. Wooder seconded by Mr. Hankin.

Treasurer's Report.

The Treasurer reported membership strength as 143, which included 12 new members to date. The cash balance, ~~including~~ <sup>after</sup> payment for overhaul of typewriter, was £135. Mr. Seymour, in proposing the acceptance of the report, wished to place on record his sincere appreciation of the work entailed in these figures. This was seconded by Mr. Wooder and passed unanimously.

Social Secretaries' Report.

In the absence of Mr. Fletcher owing to his misfortune of an accident, it was agreed to examine the question of the Dinner arrangements in detail under Item 7 - any other business.

Runs Leaders' and Editor's Report.

Mr. Drewett reported that on May 2nd it was necessary to change elevenses from Ware to Puckeridge - 14 to elevenses, 10 to lunch and 8 to tea, making 19 over the day, including Dolf Lang by moter transport. On May 30th to Aspenden, this was taken by Stan Russell and he had no details available.

### Treasurer's Report.
